Revenue Administration (Common Reporting Standard) (Amendment) Regulations, 2018

In exercise of the powers conferred by section 98 (A) of the Revenue Administration Act, the Vice-President acting as the Minister of Finance, Trade and Economic Planning hereby makes the following Regulations—

1. These Regulations may be cited as the Revenue Administration (Common Reporting Standard) (Amendment) Regulations, 2018.
